#### **Terms of Service**

1<sup>st</sup> June 2025, Please read these Terms of Service ("Terms") carefully before using the Statiofy Scholastics Ltd website or placing an order. By accessing or using our website and services, or by ordering any products, you agree to be bound by these Terms and our Privacy Policy. These Terms constitute a binding agreement between you ("you", "your", "Buyer", or "Customer") and Statiofy Scholastics Ltd ("we", "us", "our", or "Statiofy"). We are registered in Uganda with our principal office in Seeta. If you do not agree to all of these Terms, do not use the Site or place any order.

## 1. Eligibility and Account Registration

By using our Site and placing orders, you represent that you are of legal age to form a binding contract (or have obtained parental consent). You agree to provide accurate, current, and complete information when creating an account or placing an order, and to update such information as needed. You are responsible for maintaining the confidentiality of your account and password, and for any activity under your account. # 2. Modification of Terms

# 5. Refunds, Returns, and Cancellations

- No General Returns: Except as expressly provided below or required by law, all sales are
  final and non-refundable. By purchasing, you acknowledge this policy. We do not accept
  returns for a change of mind.
- Defective or Incorrect Items: If you receive a product that is defective, damaged, or not
  as described, you may request a refund or replacement. You must notify us within 7 days
  of delivery. We may require the return of the item to our address before issuing a refund
  or replacement. Refunds will be issued using the original payment method. We reserve
